# **STIPULATION**

a Justice of the Lebanon Town Court, Madison County.

IT IS HEREBY STIPULATED AND AGREED by and between Robert H.

Tembeckjian, Esq., Administrator and Counsel to the Commission, and the

Honorable John S. R. Bartlett ("respondent"), as follows.

1. Respondent has served as a Justice of the Lebanon Town Court,

Madison County, since January 2011. His current term of office expires on

December 31, 2014.

2. Respondent was personally served by the Commission with a Formal

Written Complaint dated January 2, 2013, containing two charges, which alleged

*inter alia* that:

- From in or about January 2011 through in or about January 2012 respondent failed to make timely reports to the State Comptroller with regard to the collection of fines and penalties, contrary to the requirements of Section 1803 of the Vehicle and Traffic Law, Section 27(1) of the Town Law; and
- B. Respondent failed to cooperate with the Commission's investigation of the matters set forth in Charge I of the Formal

Written Complaint, in that he failed to respond to three letters of inquiry from the Commission; failed to respond to a letter requesting that he contact Commission staff; and failed to appear on two scheduled occasions to give testimony.

3. The Formal Written Complaint is appended hereto as <u>Exhibit 1</u>.

4. Respondent enters into this Stipulation in lieu of filing a verified

Answer to the Formal Written Complaint.

5. There is no evidence that respondent converted any court funds for his or anyone else's personal use.

6. Respondent tendered his resignation from judicial office effective Might <u>51</u>, 2013, and affirms that he has vacated judicial office as of <u>311/v3</u>. A copy of respondent's resignation letter is appended hereto as <u>Exhibit 2</u>.

7. Pursuant to Section 47 of the Judiciary Law, the Commission has 120 days from the date of a judge's resignation to complete the proceedings, and if the Commission determines that the judge should be removed from office, file a determination with the Court of Appeals.

8. Respondent affirms that he will neither seek nor accept judicial office in the future.

9. Respondent understands that, should he abrogate the terms of this Stipulation and hold any judicial position at any time, the present proceedings

before the Commission will be revived and the matter will proceed to a hearing before a referee.

10. Upon execution of this Stipulation by the signatories below, this Stipulation will be presented to the Commission with the joint recommendation that the matter be concluded, by the terms of this Stipulation, without further proceedings.

11. Respondent waives confidentiality as provided by Section 45 of the Judiciary Law to the extent that (1) this Stipulation will become public upon being signed by the signatories below, and (2) the Commission's Decision and Order regarding this Stipulation will become public.

## FORMAL WRITTEN COMPLAINT

1. Article 6, Section 22, of the Constitution of the State of New York establishes a Commission on Judicial Conduct ("Commission"), and Section 44, subdivision 4, of the Judiciary Law empowers the Commission to direct that a Formal Written Complaint be drawn and served upon a judge.

2. The Commission has directed that a Formal Written Complaint be drawn and served upon John S. R. Bartlett ("respondent"), a Justice of the Lebanon Town Court, Madison County.

3. The factual allegations set forth in Charges I and II state acts of judicial misconduct by respondent in violation of the Rules of the Chief Administrator of the Courts Governing Judicial Conduct ("Rules").

4. Respondent is not an attorney. He has been a Justice of the Lebanon Town Court, Madison County, since January 1, 2011. Respondent's current term expires December 31, 2014.

### <u>CHARGE I</u>

5. From in or about January 2011 through in or about January 2012, respondent failed to make timely reports to the State Comptroller with regard to the collection of fines and penalties, contrary to the requirements of Section 1803 of the Vehicle and Traffic Law and Section 27(1) of the Town Law.

#### **Specifications to Charge I**

6. From in or about January 2011 through in or about January 2012, as set forth on the annexed <u>Schedule A</u>, respondent failed to report the collection of fines and penalties in a timely fashion to the State Comptroller, as required by Section 1803 of the Vehicle and Traffic Law and Section 27(1) of the Town Law.

7. As a result of respondent's failure to submit a timely report of such funds for the months of October, November and December 2011, the State Comptroller's Office notified the Supervisor of the Town of Lebanon, by letter dated February 14, 2012, that payment of respondent's judicial salary should be withheld. A copy of the letter is annexed as <u>Exhibit 1</u>.

8. By reason of the foregoing, respondent should be disciplined for cause, pursuant to Article 6, Section 22, subdivision (a), of the Constitution and Section 44, subdivision 1, of the Judiciary Law, in that respondent failed to uphold the integrity and independence of the judiciary by failing to maintain high standards of conduct so that the integrity and independence of the judiciary would be preserved, in violation of Section 100.1 of the Rules; failed to avoid impropriety and the appearance of impropriety, in that he failed to respect and comply with the law and failed to act in a manner that promotes

public confidence in the integrity and impartiality of the judiciary, in violation of Section 100.2(A) of the Rules; and failed to perform the duties of judicial office impartially and diligently, in that he failed to be faithful to the law and maintain professional competence in it, in violation of Section 100.3(B)(1) of the Rules, and failed to diligently discharge his administrative responsibilities and maintain professional competence in judicial administration, in violation of Section 100.3(C)(1) of the Rules.

## CHARGE II

9. Respondent failed to cooperate with the Commission's investigation of the matters set forth in Charge I above, in that he (1) failed to respond to three letters of inquiry from the Commission, (2) failed to respond to a letter requesting that he contact Commission staff and (3) failed to appear on two scheduled occasions to give testimony.

### **Specifications to Charge II**

10. By letter dated February 21, 2012, a copy of which is annexed as <u>Exhibit 2</u>, the Commission informed respondent of the allegations that he failed to file reports or remit funds in a timely fashion to the State Comptroller. The Commission's letter requested respondent's response to the allegations. Respondent failed to respond to the Commission's letter.

11. By letter dated March 16, 2012, a copy of which is annexed as <u>Exhibit 3</u>, the Commission sent to respondent a copy of its letter dated February 21, 2012, and again requested respondent's response to the allegations. Respondent failed to respond to the Commission's letter. 12. By letter dated March 29, 2012, a copy of which is annexed as
<u>Exhibit 4</u>, the Commission sent to respondent copies of its letters dated March 16, 2012, and February 21, 2012, and requested respondent's response to the allegations.
Respondent failed to respond to the Commission's letter.

13. By letter dated July 17, 2012, a copy of which is annexed as <u>Exhibit</u>
<u>5</u>, the Commission requested that respondent contact Commission staff. Respondent failed to respond to the Commission's letter.

14. By letter dated August 20, 2012, a copy of which is annexed as Exhibit 6, the Commission gave notice to respondent pursuant to Judiciary Law Section 44(3) to appear on September 4, 2012, to give testimony with respect to the matters herein at the Commission's Rochester office. On or about August 31, 2012, in a telephone call to the Commission's Rochester office, respondent advised Commission staff that he would not appear. Respondent did not request an adjournment. Respondent was advised by a Commission attorney that he would be notified of a new appearance date.

15. By letter dated September 17, 2012, a copy of which is annexed as <u>Exhibit 7</u>, the Commission gave notice to respondent pursuant to Judiciary Law Section 44(3) to appear on September 28, 2012, to give testimony with respect to the matters herein at the Commission's Rochester office. Respondent failed to appear on September 28, 2012, or on any other date. Respondent did not request an adjournment or offer any explanation for his failure to appear. 16. By reason of the foregoing, respondent should be disciplined for cause, pursuant to Article 6, Section 22, subdivision (a), of the Constitution and Section 44, subdivision 1, of the Judiciary Law, in that respondent failed to uphold the integrity and independence of the judiciary by failing to maintain high standards of conduct so that the integrity and independence of the judiciary would be preserved, in violation of Section 100.1 of the Rules; failed to avoid impropriety and the appearance of impropriety, in that he failed to respect and comply with the law and failed to act at all times in a manner that promotes public confidence in the integrity of the judiciary, in violation of Section 100.2(A) of the Rules; and failed to give his judicial duties precedence over all his other activities, in violation of Section 100.3(A) of the Rules, and failed to be faithful to the law and maintain professional competence in it, in violation of Section 100.3(B)(1) of the Rules.

WHEREFORE, by reason of the foregoing, the Commission should take whatever further action it deems appropriate in accordance with its powers under the Constitution and the Judiciary Law of the State of New York.







Pursuant to Article 2-A of the Judiciary Law, the Commission on Judicial Conduct is investigating allegations that you have failed to properly perform your administrative and financial duties.

Specifically, it is alleged that for the period from October 2011 through December 2011, you did not file your reports with the State Comptroller and remit court funds to the Town of Lebanon within ten days of the month succeeding collection as required by Sections 2020 and 2021 of the Uniform Justice Court Act, Section 1803 of the Vehicle and Traffic Law and Section 27 of the Town Law (see enclosed Schedule B), with the result that payment of your salary was ordered stopped by the State Comptroller's Office on or about February 14, 2012.

At your appearance, you will also be questioned about your failure to respond to letters I sent to you on February 21, 2012, March 16, 2012, March 29, 2012, and July 17, 2012, concerning the allegations (copies are enclosed).


