IT IS HEREBY STIPULATED AND AGREED by and between Rober
H. Tembeckjian, Esq., Administrator and Counsel to the Commission, the Honorable
James E. Chase ("respondent"), and Michael F. Young, Esq., respondent's counsel, as
follows.
1. Respondent has served as a Justice of the Turin Town Court since
August 1, 1998. He is not an attorney. His current term of office expires on December
31, 2011. At all times relevant herein, the Turin Town Court had a single justice.
2. Respondent was served by the Commission with a Formal Written
Complaint dated August 30, 2011, which alleged that respondent failed to:
A. regularly deposit all court funds within 72 hours of receipt, as

required by law, with the result that, on March 2, 2009, the court

account's cumulative deficiency reached \$6,080.00;

- B. notify the Commissioner of Motor Vehicles, as required by law, to order the suspension of the drivers' licenses of 1,008 traffic defendants who failed to appear in response to their traffic charges;
- C. notify the Commissioner of Motor Vehicles, as required by law, to order the suspension of the drivers' licenses of 320 traffic defendants who failed to pay fines and surcharges totaling \$54,465.00, imposed following their convictions;
- D. schedule or take other action pursuant to law to dispose of 276 traffic cases in which defendants had pleaded not guilty to their charges;
- E. notify the Commissioner of Motor Vehicles, as required by law, of the convictions of 14 traffic defendants, and;
- F. properly administer his court by mishandling court funds with the result that as of December 31, 2010, the court had only \$3,162.36 in unencumbered funds available to cover the pending disposition of \$30,180.00, in bail.

The Formal Written Complaint is appended hereto as Exhibit 1, and respondent's Answer is appended hereto as Exhibit 2.

3. Respondent tendered his resignation from judicial office on November 30, 2011, effective December 8, 2011, and has submitted copies to the Town of Turin and the Office of Court Administration. Copies of the respondent's resignation letters are appended hereto as Exhibit 3 and Exhibit 4.

- 4. Respondent affirms that he will neither seek nor accept judicial office in the future.
- 5. Respondent has notified the Department of Audit and Control about the Commission's investigation and has requested an audit of the court.
- 6. All the parties to this Stipulation respectfully request that the Commission close the pending matter based upon this Stipulation.
- 7. Respondent waives confidentiality as provided by Section 45 of the Judiciary Law to the limited extent that this Stipulation will be made public if accepted by the Commission.

FORMAL WRITTEN COMPLAINT

a Justice of the Turin Town Court, Lewis County.

- 1. Article 6, Section 22, of the Constitution of the State of New York establishes a Commission on Judicial Conduct ("Commission"), and Section 44, subdivision 4, of the Judiciary Law empowers the Commission to direct that a Formal Written Complaint be drawn and served upon a judge.
- The Commission has directed that a Formal Written Complaint be drawn and served upon James E. Chase ("respondent"), a Justice of the Turin Town Court, Lewis County.
- 3. The factual allegations set forth in Charges I through VI state acts of judicial misconduct by respondent in violation of the Rules of the Chief Administrator of the Courts Governing Judicial Conduct ("Rules").
- 4. Respondent has been a Justice of the Turin Town Court, Lewis County, since August 1, 1998. Respondent's current term expires December 31, 2011.
 Respondent is not an attorney. At all times relevant herein, the Turin Town Court had a single justice.

CHARGE I

5. From on or about January 14, 2009 to on or about December 22, 2010, as set forth in the annexed Schedules A-1, A-2, and A-3, respondent regularly failed to deposit all of the funds received into the court account within 72 hours of receipt as required by Section 214.9 of the Uniform Civil Rules for the Justice Court. During that period, on 27 occasions respondent failed to deposit the full amount received by the court in a timely manner.

Specifications to Charge I

January 14, 2009 to June 23, 2009

- 6. From on or about January 14, 2009 to on or about June 23, 2009, respondent failed to deposit all of the funds received into the court account within 72 hours of receipt, with the result that the funds received during that period exceeded the funds deposited by \$4,955.00, as set forth on the annexed <u>Schedule A-1</u>.
- 7. Respondent made thirteen deposits into the court account in which the amount of money deposited did not match the sum of funds received by the court since the previous deposit. On eight occasions, the amount respondent deposited was less than the amount received by his court since the previous deposit, and on five occasions the amount deposited was more than the amount received since the previous deposit.
- 8. During the six-month period between January 14, 2009 and June 23, 2009, the cumulative deficiency in respondent's court account was consistently more than \$2,300.00, and on March 2, 2009, the deficiency reached \$6,080.00. On June 23, 2009, the cumulative deficiency was \$4,955.00.

July 30, 2009 to February 23, 2010

- 9. From on or about July 30, 2009 to on or about February 23, 2010, respondent failed to deposit all of the court funds received into the court account within 72 hours of receipt, with the result that the funds received during that period exceeded the funds deposited by \$3,175.00, as set forth on the annexed <u>Schedule A-2</u>.
- 10. Respondent made sixteen deposits into the court account in which the amount deposited did not match the sum of the funds received by the court since the previous deposit. On ten occasions the amount respondent deposited was less than the amount received by his court since the previous deposit, and on six occasions the amount deposited was more than the amount received since the previous deposit.
- 11. The cumulative deficiency in respondent's court account for the period from on or about July 30, 2009 to on or about February 23, 2010, was \$3,175.00.

March 12, 2010 to December 22, 2010

- 12. From on or about March 12, 2010 to on or about December 22, 2010, respondent failed to deposit all of the court funds received into the court account within 72 hours of receipt, with the result that the funds received during that period exceeded the funds deposited by \$800.00, as set forth on the annexed <u>Schedule A-3</u>.
- 13. Respondent made nineteen deposits into the court account in which the amount of the money deposited did not match the sum of funds received by the court since the previous deposit. On nine occasions the amount that respondent deposited was less than the amount received by his court since the previous deposit, and on ten

occasions the amount deposited was more than the amount received since the previous deposit.

- 14. The cumulative deficiency in respondent's court account for the period from on or about March 12, 2010 to on or about December 22, 2010, was \$800.00.
- cause, pursuant to Article 6, Section 22, subdivision (a), of the Constitution and Section 44, subdivision 1, of the Judiciary Law, in that respondent failed to uphold the integrity and independence of the judiciary by failing to maintain high standards of conduct so that the integrity and independence of the judiciary would be preserved, in violation of Section 100.1 of the Rules; failed to avoid impropriety and the appearance of impropriety, in that he failed to respect and comply with the law and to act in a manner that promotes public confidence in the integrity and impartiality of the judiciary, in violation of Section 100.2(A) of the Rules; and failed to perform the duties of judicial office impartially and diligently, in that he failed to be faithful to the law and maintain professional competence in it, in violation of Section 100.3(B)(1) of the Rules, and failed to diligently discharge his administrative responsibilities and maintain professional competence in judicial administration, in violation of Section 100.3(C)(1) of the Rules.

CHARGE II

16. From on or about February 23, 1999 to the present, respondent has failed to notify the Commissioner of Motor Vehicles, pursuant to Section 514(3) of the Vehicle and Traffic Law, to order the suspension of the drivers' licenses of the 1,008 defendants identified on the annexed <u>Schedule B</u>, notwithstanding that such defendants

have been charged with violations of the Vehicle and Traffic Law and have failed to answer those charges.

cause, pursuant to Article 6, Section 22, subdivision (a), of the Constitution and Section 44, subdivision 1, of the Judiciary Law, in that respondent failed to uphold the integrity and independence of the judiciary by failing to maintain high standards of conduct so that the integrity and independence of the judiciary would be preserved, in violation of Section 100.1 of the Rules; failed to avoid impropriety and the appearance of impropriety, in that he failed to respect and comply with the law and to act in a manner that promotes public confidence in the integrity and impartiality of the judiciary, in violation of Section 100.2(A) of the Rules; and failed to perform the duties of judicial office impartially and diligently, in that he failed to be faithful to the law and maintain professional competence in it, in violation of Section 100.3(B)(1) of the Rules, and failed to diligently discharge his administrative responsibilities and maintain professional competence in judicial administration, in violation of Section 100.3(C)(1) of the Rules.

CHARGE III

18. From on or about November 2, 1999 to on or about July 1, 2011, respondent has failed to notify the Commissioner of Motor Vehicles, pursuant to Section 514(3) of the Vehicle and Traffic Law, to order the suspension of the drivers' licenses of the 320 defendants identified on the annexed <u>Schedule C</u>, notwithstanding that such defendants have failed to pay fines and surcharges, totaling \$54,465.00, imposed following their convictions.

cause, pursuant to Article 6, Section 22, subdivision (a), of the Constitution and Section 44, subdivision 1, of the Judiciary Law, in that respondent failed to uphold the integrity and independence of the judiciary by failing to maintain high standards of conduct so that the integrity and independence of the judiciary would be preserved, in violation of Section 100.1 of the Rules; failed to avoid impropriety and the appearance of impropriety, in that he failed to respect and comply with the law and to act in a manner that promotes public confidence in the integrity and impartiality of the judiciary, in violation of Section 100.2(A) of the Rules; and failed to perform the duties of judicial office impartially and diligently, in that he failed to be faithful to the law and maintain professional competence in it, in violation of Section 100.3(B)(1) of the Rules, and failed to diligently discharge his administrative responsibilities and maintain professional competence in judicial administrative responsibilities and maintain professional

CHARGE IV

- 20. From on or about March 18, 1999 to the present, respondent has failed to schedule or take other action pursuant to law to dispose of 276 cases, as set forth on the annexed <u>Schedule D</u>, in which defendants have pleaded not guilty to alleged violations of the Vehicle and Traffic Law. The 276 cases remain pending, with no further proceedings or actions scheduled.
- 21. By reason of the foregoing, respondent should be disciplined for cause, pursuant to Article 6, Section 22, subdivision (a), of the Constitution and Section 44, subdivision 1, of the Judiciary Law, in that respondent failed to uphold the integrity

and independence of the judiciary by failing to maintain high standards of conduct so that the integrity and independence of the judiciary would be preserved, in violation of Section 100.1 of the Rules; failed to avoid impropriety and the appearance of impropriety, in that he failed to respect and comply with the law and to act in a manner that promotes public confidence in the integrity and impartiality of the judiciary, in violation of Section 100.2(A) of the Rules; and failed to perform the duties of judicial office impartially and diligently, in that he failed to be faithful to the law and maintain professional competence in it, in violation of Section 100.3(B)(1) of the Rules, and failed to diligently discharge his administrative responsibilities and maintain professional competence in judicial administration, in violation of Section 100.3(C)(1) of the Rules.

CHARGE V

- 22. From on or about October 18, 1999 to the present, respondent has failed to notify the Commissioner of Motor Vehicles, as required by Section 514(1)(a) of the Vehicle and Traffic Law, of the convictions, between October 18, 1999 and October 31, 2005, of the fourteen defendants set forth in the annexed <u>Schedule E</u>.
- 23. By reason of the foregoing, respondent should be disciplined for cause, pursuant to Article 6, Section 22, subdivision (a), of the Constitution and Section 44, subdivision 1, of the Judiciary Law, in that respondent failed to uphold the integrity and independence of the judiciary by failing to maintain high standards of conduct so that the integrity and independence of the judiciary would be preserved, in violation of Section 100.1 of the Rules; failed to avoid impropriety and the appearance of impropriety, in that he failed to respect and comply with the law and to act in a manner

that promotes public confidence in the integrity and impartiality of the judiciary, in violation of Section 100.2(A) of the Rules; and failed to perform the duties of judicial office impartially and diligently, in that he failed to be faithful to the law and maintain professional competence in it, in violation of Section 100.3(B)(1) of the Rules, and failed to diligently discharge his administrative responsibilities and maintain professional competence in judicial administration, in violation of Section 100.3(C)(1) of the Rules.

CHARGE VI

24. Respondent has failed to properly administer his court and has mishandled court funds with the result that as of December 31, 2010, the court had only \$3,162.36 in unencumbered funds available to cover the pending disposition of \$30,180.00 in bail that had been received by the court between September 3, 2002 and December 6, 2010, as set forth on the annexed <u>Schedule F.</u>

Specifications to Charge VI

- 25. As of December 31, 2010, there were 36 cases in respondent's court in which there was pending bail, as set forth on the annexed <u>Schedule F</u>. The amount of bail received by respondent in those 36 cases totaled \$30,180.00.
- 26. As of December 31, 2010, the balance in the court account totaled \$7,222.36. Of that amount, \$4,060.00 was owed to the State Comptroller or to the Chief Fiscal Officer of the Town of Turin, in connection with the monthly remission of fines collected in traffic cases and due to be paid by January 10, 2011, as required by Section 1803 of the Vehicle and Traffic Law, Section 27(1) of the Town Law, Sections 2020 and 2021 of the Uniform Justice Court Act, and Section 99-a of the State Finance Law.

- 27. As a result, as of December 31, 2010, the court had only \$3,162.36 in unencumbered funds available to cover the pending disposition of \$30,180.00 in bail that had been received by the court between September 3, 2002 and December 6, 2010, as set forth on the annexed <u>Schedule F</u>. The remaining \$27,017.64 of the bail money collected during that period has not been accounted for.
- 28. As of December 31, 2010, there were no outstanding court financial liabilities beyond bail and the amounts owed to the State Comptroller and the Chief Fiscal Officer of the Town of Turin, as set forth above.
- 29. By reason of the foregoing, respondent should be disciplined for cause, pursuant to Article 6, Section 22, subdivision (a), of the Constitution and Section 44, subdivision 1, of the Judiciary Law, in that respondent failed to uphold the integrity and independence of the judiciary by failing to maintain high standards of conduct so that the integrity and independence of the judiciary would be preserved, in violation of Section 100.1 of the Rules; failed to avoid impropriety and the appearance of impropriety, in that he failed to respect and comply with the law and failed to act in a manner that promotes public confidence in the integrity and impartiality of the judiciary, in violation of Section 100.2(A) of the Rules; and failed to perform the duties of judicial office impartially and diligently, in that he failed to be faithful to the law and maintain professional competence in it, in violation of Section 100.3(B)(1) of the Rules, and failed to diligently discharge his administrative responsibilities and maintain professional competence in judicial administration, in violation of Section 100.3(C)(1) of the Rules.

WHEREFORE, by reason of the foregoing, the Commission should take whatever further action it deems appropriate in accordance with its powers under the Constitution and the Judiciary Law of the State of New York.
