# St. Lawrence County Town Court Justice Should Be Admonished for Making a Facebook Post About a Pending Proceeding

The New York State Commission on Judicial Conduct has determined that Lisa J. Whitmarsh, a Justice of the Morristown Town Court, St. Lawrence County, should be admonished for making public comments on Facebook concerning a pending proceeding.

Judge Whitmarsh agreed to the admonition.

In 2016, Judge Whitmarsh, made a post on her Facebook page criticizing the investigation and prosecution of David VanArnam, who had been charged in another town court with falsely swearing that he had personally witnessed signatures on nominating petitions in support of his candidacy for the Morristown Town Council. The judge also clicked the "like" button next to some comments to her post.

In its determination the Commission stated that Judge Whitmarsh's Facebook comments "addressed the defendant's culpability...and criticized the prosecution

in intemperate language, suggesting that it arose from a 'personal vendetta' and that the investigation was the product of 'CORRUPTION' caused by 'personal friends calling in personal favors,' and that Mr. VanArnam had '[a]bsolutely' no criminal intent." As a result of her posts, the judge eventually recused herself from all matters involving the District Attorney.

The Commission stated that the judge's comments and her "likes" of other posts "conveyed not only [the judge's] personal view that the prosecution was unjust, but the appearance that she was impugning the integrity of the prosecution and endorsing others' criticisms of the District Attorney's office and the District Attorney personally."

Judge Whitmarsh, who is not an attorney, has served as a Justice of the Morristown Town Court since 2014. Her current term expires on December 31, 2017.

# **The Commission Proceedings**

Judge Whitmarsh was served with a Formal Written Complaint dated October 28, 2016, containing one charge, and filed an Answer dated November 16, 2016.

On December 2, 2016, the Administrator of the Commission, Judge Whitmarsh and Judge Whitmarsh's attorney entered into an Agreed Statement of Facts, stipulating as to the facts and sanction and waiving further submissions and oral argument.

The Commission accepted the Agreed Statement on December 7, 2016.

# **The Commission Determination**

The Commission filed a determination dated December 28, 2016, in which ten members concurred: Joseph W. Belluck, Esq. (the Commission Chair), Paul B. Harding, Esq. (the Vice Chair), Judge Rolando Acosta, Joel Cohen, Esq., Jodie Corngold, Richard D. Emery, Esq., Judge Thomas A. Klonick, Judge Leslie G. Leach, Richard A. Stoloff, Esq., and Judge David A. Weinstein.

One member, Akosua Garcia Yeboah, did not participate.

#### **Statement by Commission Administrator**

Commission Administrator Robert H. Tembeckjian made the following statement.

"The proliferation of social media poses special concerns for judges and others who are bound by promulgated codes of ethics, particularly in an era where so little is truly private. On or off the bench, in person or by electronic communication, a judge must observe high standards of conduct and act at all times in a manner that promotes public confidence in the judiciary."

## **Court of Appeals Review**

The Commission transmitted its determination to the Chief Judge of the Court of Appeals, pursuant to Judiciary Law Section 44, subdivision 7. Judge Whitmarsh received it on January 5, 2017, and the Commission was subsequently notified by the Court of Appeals that service was complete. Consequently, the matter is now public.

A judge may either accept the Commission's determination or, within 30 days from receipt, make a written request to the Chief Judge for a review of the determination by the Court of Appeals.

Pursuant to Judiciary Law Section 44, subdivision 7, if Judge Whitmarsh does not request review by the Court of Appeals, the Commission will admonish her in accordance with the determination.

If a Commission determination is reviewed by the Court of Appeals, the Court may accept the determined sanction, impose a different sanction including admonition, censure or removal, or impose no sanction.

#### **Statistics Relating to Prior Determinations**

Since 1978, the Commission has issued 266 determinations of admonition against judges in New York State. The Commission has issued 169 determinations of removal and 316 determinations of censure.

The Court of Appeals has reviewed 96 Commission determinations. The Court accepted the Commission's sanctions in 80 cases (71 of which were removals, six were censures and three were admonitions). Of the remaining 16 cases, two sanctions were increased from censure to removal, and 13 were reduced: nine removal determinations were modified to censure, one removal was modified to admonition, two censures were modified to admonition, and one censure was

rejected and the charges dismissed. The Court remitted one matter to the Commission for further proceedings.
